815	Police Report. Sgt Wilson report on illegal parking on Birds Hill has been previously circulated Monitoring in the period 13 th to 30 th September resulted in four letters being sent to transgressors. The police are having difficulty providing the manpower to provide continuing monitoring but the Parish Council are extremely concerned that illegal parking will result in a serious accident.

816.1	Christmas Tree Update. The Clerk contacted the supplier of the planted Christmas tree who has offered to replace the tree in the New Year. There were different views on the best location of the tree and it was agreed to discuss the best location with the supplier.	
816.2	HGVs through the village: Gary Baldwin from CBC emailed the results of the consultation on 3 rd November. Heath and Reach is not mentioned in these restrictions which is unacceptable. Clerk to ask Cllr Versallion to continue to exert pressure.	
816.3	Speed Limits in the village: Nothing further to report. Delivery of SID due end of January. Speed watch action can then be taken.	
816.4	Grit Bins update: One has been installed in Emu Close and one in Abbey Walk.	
816.5	Sandhouse Link update: Cllr Beilby reported that Ian Foll of Arnold White Estates is keen on reopening this foot path and will need to discuss this with CBC.	
816.6	Community Woodland update – Cllr Beilby and Esther Clarke inspected the area on 30 th November the bike jumps have been levelled but there is still a fence in place between the lower section trees and the top half meadow. The Parish Council have been donated 200 + trees from St Leonard's School and this could be good area to plant, final location of trees to be agreed as there are other area in the village that could benefit. Cllr Beilby to ask James Hoare if he could photograph the area with a drone. Clerk awaiting a response from Arnold White Estates regarding the new lease. And no work should be undertaken until this lease has been agreed.

Another speaker Juliet Wright of Bedfordshire Police spoke about various watch schemes in Parishes, e.g. neighbourhood, speed and streetwatch. The number of schemes operating in
