| | the village. Subject to approval he will sign a 5 year agreement to rent the building | |
| | for use as a gym at a rental of £7000 per annum, responsible for all maintenance | |
| | and pro rata proportion of the utilities and will manage the Boxing Club within this | |
| | agreement. They are committed to ensuring it will be community focussed providing a free class for the over 65 years old residents in the village. They have | |
| | plans for a summer sports day and will support a local charity with funds raised | |

| | has opened up the approach and would like the Parish Council to request | |
| | Greensand Trust to provide a safe footpath from the village to Rushmere. Cllr | |

| | discuss the problem with weight of traffic and speeding through the village. They observed the three main routes and it is apparent that they are looking at a | |
| | massive end to end project with design planning and consultation from April 2020 | |
| | and implementation from April 2021 and a possible £250,000 anticipated budget | |
| | part of which will be funded by the Parish Council . CBC will consult the village on | |
| | proposals. Suggestions to date are to create gateways to the village – e.g. Woburn | |
| | Road speed sign is confusing at present, so the idea is to give a visual indication to | |
| | the entrances to the village. Also to narrow the road at Leighton Road , again, to | |
| | define entrance to the village. Another suggestion to install a short 40mph limit | |
| | between Shenley hill road and the church. Cllr Boyden said the concerns of the | |
| | village are now being heard and are being addressed by the correct departments | |
