- b) Cemetery clerk paid position A request was made to allow the budget to cover a paid position for the Cemetery clerk. This was originally due to be a voluntary role, carried out by the previous clerk following her resignation from full clerk position. However, it was agreed that the work is necessary and therefore should be paid. Clerk to speak to cemetery clerk and advise accordingly.
- c) Possible land purchase on budget This is shown on the budget. The PC has no plans to purchase any land, so it was agreed the allocated money is transferred to the clock tower repairs as these are expected to be very expensive.
- d) Precept & budget Final adjustments to be made and emailed to Councillors for approval as this needs to be sent to CBC by the 19<sup>th</sup> January.
- e) Bryants Lane toilet block flooded The toilet block has suffered with frozen burst pipes and are currently out of action. Expected repair cost £500 £600. Clerk asked to organise a plumber, if quote is within this amount, go ahead. If over £1000 3 quotes needed. Clerk requested to check insurance and add the toilet block to it.
- f) Sand & debris follow up Cllr. Boyden has spoken to the 2 quarries close by and they are working hard to keep area clear.
- g) CBC Highways Signs inconveniently placed signs have been removed, no further action.
